★ Full Terms & Conditions (PowerShare Team)

1. Introduction

1.1. These Terms and Conditions (“Terms”) govern participation in the PowerShare Team Programme (“PowerShare Team”) operated by Geo Green Power (“the Company”).

1.2. The PowerShare Team Programme provides employee benefits linked to participation in the PowerShare Business Referral Programme or qualifying commercial projects.

1.3. By participating, all eligible individuals agree to be bound by these Terms.

2. Eligibility

2.1. The PowerShare Team Programme is open to employees of existing commercial customers of Geo Green Power.

2.2. To qualify, the customer organisation must have had a fully installed solar PV system completed by Geo Green Power within the previous five (5) years.

2.3. Eligibility is limited to individuals who are:

- Current employees of the qualifying commercial customer; and
- Able to provide reasonable proof of employment if requested by the Company.

2.4. The Company reserves the right to verify both:

- The eligibility of the commercial customer; and
- The employment status of any individual claiming the benefit.

2.5. To be eligible for the discount employees must be either full-time, part-time or within a fixed term contract with the customer organisation at the start of the installation.

2.6. The programme is not available to agents, or consultants working on behalf of the customer organisation.

3. Programme Benefit

3.1. Eligible participants are entitled to:

A £500 discount on qualifying domestic installations.

3.2. Qualifying installations include:

- Solar PV systems
- Home battery systems
- Heat pump systems
- Any combination of the above technologies

4. Discount Application

4.1. The £500 discount:

- Applies to the total installation price (excluding VAT unless otherwise stated);
- Applies only to residential/domestic installations;
- Must be declared at the point of quotation.

4.2. The discount cannot be retrospectively applied once a quotation has been accepted or installation has begun.

5. Validity Period

5.1. The PowerShare Team benefit becomes active when the associated commercial project:

Is completed and commissioned

5.2. The discount remains valid for:

5 years from the date of the commercial project's final invoice.

6. Limitations

6.1. The benefit:

- Is limited to one use per household unless otherwise agreed
- Cannot be transferred to non-eligible individuals
- Cannot be exchanged for cash or alternative discounts

6.2. The discount cannot be used in conjunction with:

Any other promotions, referral incentives, or special offers unless expressly approved by the Company.

7. Referral Independence

7.1. Participation in the PowerShare Team Programme does not:

- Create any employment, agency, or partnership relationship with the Company
- Entitle participants to commission, referral fees, or commercial rewards

7.2. The programme is strictly a customer benefit scheme, not a sales incentive scheme.

8. Fraud, Misuse & Disqualification

8.1. The Company reserves the right to:

- Withdraw access to the programme
- Cancel discounts
- Refuse service

Where it reasonably suspects:

- Misrepresentation of eligibility
- Abuse of the scheme
- Unauthorised sharing of benefits

9. Changes to the Programme

9.1. The Company reserves the right to:

- Amend, suspend, or withdraw the PowerShare Team Programme at any time
- Modify discount levels or eligibility criteria

9.2. Any changes will not affect confirmed installations already under contract.

10. General

10.1. These Terms are governed by the laws of England & Wales.

10.2. If any provision is deemed invalid, the remaining provisions will remain in full effect.

10.3. The Company's decision regarding eligibility and application of the programme is final.
